3. Ron Reese reminded the Committee that we now have a prayer team. If you would like to be a member of this team and have not yet contacted Ron, please do so.
4. Ken Ham will be the speaker the Christian Leadership Meeting, replacing Carl Kirby. Dr David Menton may be the second speaker at the May Conference, potentially replacing Mike Riddle. Cris Loop has three phone callers from Fauquier County and now feels she has Fauquier County covered. She will serve as the Fauquier County Coordinator. Arlington, Alexandria, Loudon and Prince Georges Counties are not covered with a County

Coordinator and are considered critical. Lanny Larrimore will serve as Spotsylvania County Coordinator, in addition to serving as King George County Coordinator.

5. . 6. Chap went over the flow diagram of CLM Invitation and Outreach chart. Callers start calling for the CLM meeting on Feb 22 [At the meeting Chap had in error said February 19].

a. Fred Pearce covered building the church list. There are 442 churches on the list currently on Montgomery County, about the same as 1997 (422). www.yellowpages.com is the preferred website to find zip code, and sorts by denomination, county, etc.

b. Cris Loop covered the 5a –Instructions for coming up with county lists_cris Loop .pdf file that was e-mailed. There are about 15 additional churches in Fauquier County over 1997, however, the list is not complete.

c. Leslie Little went over her pdf file, and how she cleaned up her list. Chap went over his techniques for Loudoun County. We may need to use word of mouth or Google searches for churches meeting in schools. Denominational churches may have a website to find local churches; we have the list of supporting denominations with links to their denominational Web site (church finder) in Word format. Chap will e-mail this file to the county coordinators. The official list of abbreviations was covered by Leslie Little. Fernando De Souza went over changing records for churches on the SERVER. We will use the SERVER to update the Church list, since it is easily done, and it is viewable by everyone. Committee members or callers, who wish to be added as Local Creation Contacts can updated that information themselves. This is the beauty of having the church list file on the Server.

d. Chap also went over a manual approach to updating churches, using a PDF file of each County, with one church per page printed. This manual list can be used for calling purposes, verification of information manually, using a phone book to verify information, etc. Once the material is looked up, someone can key it in. Chap will put these PDFs on his Web Site. Fred wanted to add fields for “Senior Pastor Contacted, Y/N/”, “Date_Senior Pastor Contacted”, “Who Contacted Senior Pastor”, and a “Notes” field of at least 80 characters.

e. On the third Saturday of September and the 3rd Saturday in October, the Committee will meet at Blue Ridge Bible Church for list construction on counties that don’t have a county coordinator. Chap requested a show of hands that will be there. He will follow up with an e-mail.
